

## Tonopah Rob's Farm Stand CSA Registration Form

By signing below, I am entering into a contract with Tonopah Rob's Vegetable Farm to participate in the Farm Stand CSA program. I will pay for either a half or a full share and in turn be able to pick up vegetables on Saturday or Sunday at one of Tonopah Rob's Vegetable Farm locations (which will be posted on <http://www.tonopahrob.com>). Every time I pick up vegetables, the cost is deducted from my credit, which is my initial payment amount. I am not obligated to pick up my share every week but am allowed to pick up any amount of produce not to exceed my credit. If I am not able to pick up my share or have someone else pick up my share and there is a balance remaining at the end of the season, that balance is forfeited, no exceptions will be made.

**Payment options:** The Farm Stand CSA cost of subscribing is \$200 for a half share, and \$500 for a full share. There is NO option for making monthly payments, all payments must be in full prior to picking up any produce.

**Additionally:** Farm Stand CSA shares will be filled by the subscribers. It is best to arrive early for the best selection. Subscribers are allowed to pick any combination and weight of produce they wish pending availability. There is no guarantee of availability or quantity implied as Tonopah Rob's Vegetable Farm and Farm Stands operate on a first-come first-served basis. Harvest varies from week to week, while one week may result in an abundance, the following week may not, this is part of the nature of belonging to a CSA – local farms do not always produce enough to meet every subscribers expectations. Fluctuations occur due to harvest capacity as determined by the workings of nature, the weather, and circumstances out of the farmer's control.

**Bugs, dirt, non-uniformity, blemishes:** Tonopah Rob's farm produces all-natural produce grown in the dirt where bugs, birds, pests, and other creatures live, as such the occasional insect, a fair share of dirt, and veggies that are not uniform and may have blemishes will end up in subscribers' shares.

**Farm Season:** Farm Stand CSA shares should become available on November 6, 2010 with the last opportunity to fulfill shares ending July 17, 2011. We will be closed on the following weekends: 11/27-28, 2010, 12/25-26, 2010, and 1/1-2 2011, and one Saturday and Sunday in February (exact dates to be determined). If conditions warrant I may be forced to postpone a weekly market from time to time to allow the farm to grow enough produce to meet harvest demands.

**Refunds:** *We cannot stress enough that there will not be any refunds given for any reason during this agreement.* Subscribers may donate or give their share away, split share with friend or family member, or cancel further pickups – with the understanding there is a **NO refund policy**.
